Business Psychology: Business is more than Numbers

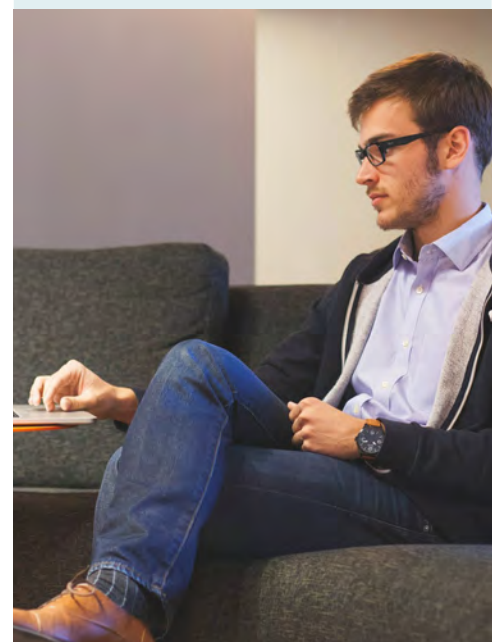
People are paramount for economy. Moods, personal experiences or patterns of action influence decisions. Knowing psychological processes makes it easier to understand companies.

- Relevant professionally qualifying university degree according to §10 BerlHG
- Completed Bachelor's degree in economics or
- Completed Bachelor's degree with a minimum of 60 ECTS in economics modules
- English C1 proficiency in line with the Common Framework of Reference for Languages
- Motivational letter (max. 1 DIN A4 page)
- Scan of your ID or equivalent identification document (front and back)
- Curriculum vitae
- Foreign Bachelor's degrees must be reviewed for equivalence in accordance with the Central Office for Foreign Education (ZAB).

Tuition Fees and Financing Options

The tuition fees for the BSP Master of Business Administration amount to Euro 16,560, to be paid in 24 equal monthly installments of Euro 690 in the full-time model, with an additional non-recurrent administrative enrollment fee of Euro 100. There are numerous possibilities for financing your studies, e.g. BAföG, KfW Studienkredit (student loan, independent of parents and study program without collateral), scholarship for gifted students, student loans from banks, student education funds, and scholarships.
